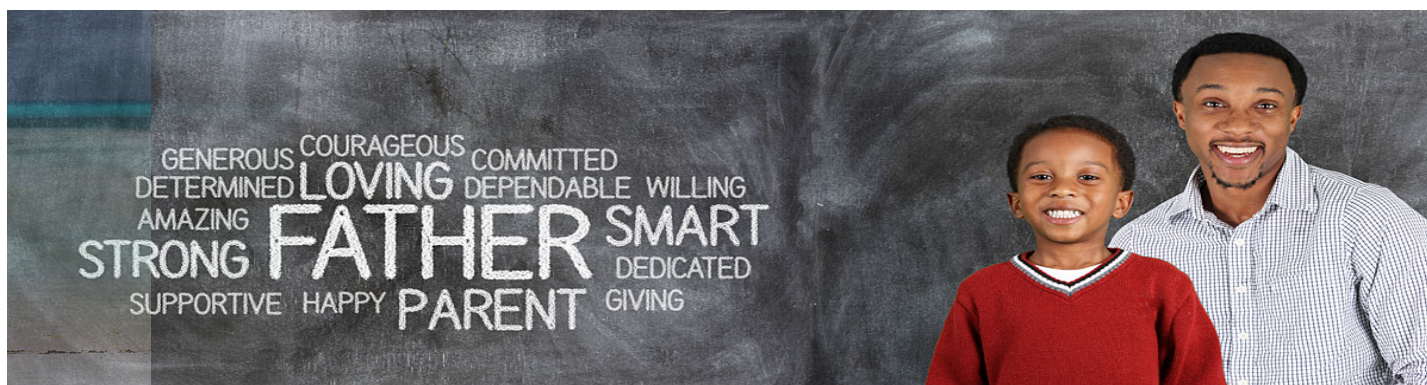

FER involvement and referrals have assisted over 500,000 families improve the quality of life for children and promote "what is in the best interest" of our children.
